C. ACTION ITEMS:

1. APPROVAL OF THE 2121 TAX RELIEF.

April Hatfield (Deputy Clerk, Board of Equalization): State legislature allows tax relief to be granted by the county for a variety of reasons including veterans with a disability, elderly with lower income, indigent, blind, and deployed military. Weber County approved a total of 4,666 applications last year, an increase of 86 from last year. 3,517 of those were veterans with a disability; 921 were elderly with lower income (Circuit Breaker program), 254 were indigent; 98 were blind; and 24 were deployed military. Total abatement allotted a little over \$7.2M or a little over 2.34% of total tax collections.

2. APPROVAL OF THE 2021 APPEALS AND JOURNAL ENTRIES.

April Hatfield (Deputy Clerk, Board of Equalization): Weber County sent out 99,382 valuation notices last year with a record low number of appeals of 645 total appeals; last year appeals were just under 1,000 and the year before that was just under 2,000. 118 appeals were not accepted due to lack of evidence, not timely, etc. 527 accepted appeals with 171 with no adjustments made and 356 had some adjustment made to the value, just 0.36% of notices mailed. 1,642 journal vouchers processed with 591 being value adjustments and 1051 being direct charge adjustments.

3. APPROVAL OF THE 2022 PROPERTY TAX EXEMPTION FILINGS.

April Hatfield (Deputy Clerk, Board of Equalization): One additional exempt organization to add to the list previously routed, the Mitchell Foundation. Exempt org filings with three new approved organizations and two that discontinued operations for a total of 169 active exempt organizations with 80 religious, 7 educational, and 82 charitable.

Commissioner Jenkins moved to approve the 2022 Property Tax Exemption Filings; Commissioner Froerer seconded.
