

**MINUTES OF THE WORK SESSION OF

**Discussion and/or action for approval of minutes for the Commission Work Session held on January 5, 2026**

*Commissioner Harvey made a motion to approve the minutes for the Commission Work Session held on January 5, 2026. Commissioner Bolos seconded the motion. All voted aye. The motion carries.*

**Discussion regarding SHPO Certified Local Government Program** – Sean Wilkinson, Stephanie Russell, Jessika Park, Chris Crockett

Sean Wilkinson and Stephanie Russell discussed the benefits and potential challenges of establishing a historic preservation commission, including funding opportunities and jurisdictional issues. They agreed to further investigate properties with historical significance in unincorporated areas and explore the possibility of securing funding. The Commissioners would like Stephanie to do more research on this subject, including whether there would be any benefit to Weber County to have a historic preservation commission, and present what she finds at a future work session.

**Discussion regarding Meibos Rezone and Development Agreement** – Felix Lleverino, Rick Grover, Charlie Ewert, Gary Myers, Liam Keogh, Sean Wilkinson, Tucker Weight, Chris Crockett, Stephanie Russell, Pat Burns

Felix Llelverino discussed the Meibos rezone and Development Agreement, focusing on traffic impact studies and improvements. He presented updates on the development plan, including density adjustments, pathways, and proposed road improvements. He also discussed meeting with the Planning Commission regarding the updated development, and they gave a unanimous recommendation for this project. The Commissioners expressed concerns about vague traffic improvement details in the agreement, emphasizing the need for specific requirements based on a comprehensive traffic study that the developer had done. The Commissioners would like Gary Myers to review the developer's traffic study and then present his findings to the Commissioners at a future work session.

**Discussion regarding Youth Violence Intervention Program** – Jim Retallick, Jessika Clark,

Jim Retallick presented a proposal for a Youth Violence Intervention Program, which would involve hiring a coordinator in Weber County to address juvenile violence through mentorship and resource coordination. He discussed the success of this program in Salt Lake County and presented information from a study done by the CCJJ in 2025 showing Weber County has 7 locations in the top 20 for juvenile violence. Jim also discussed that they are in the process of presenting a bill to the State to acquire funding for this program.
