**Discussion regarding Discuss Crossing Guard Help with West Haven – Matthew Jensen (West Haven City Manager), Sean Wilkinson, Sheriff Ryan Arbon**

The Commissioners met with Matthew Jensen, West Haven City Manager, regarding Weber County providing Crossing Guard help at 3300 S and 3500 W, as three quarters of that area is in unincorporated Weber County. This area services West Haven and Weber County residents and their families. Matthew Jensen stated West Haven would be happy to staff the Crossing Guard position, but would like Weber County to provide compensation for this position. Sheriff Arbon was asked to join this meeting. He stated that it is the cities that pay for the Crossing Guards, but his department has paid for one Crossing Guard in the Ogden Valley. Sheriff Arbon suggested Matthew start with the School District first, and if it meets their criteria, then he can contact the Sheriff's office and they will help out as this is a public safety issue. Matthew will be in touch with the Sheriff once he speaks to the School District.

**Sheriff's Office Update – Sheriff Ryan Arbon**

- Sheriff Arbon discussed the Self-Reliance Fair, which will be October 7<sup>th</sup> through October 9<sup>th</sup>.
- The Sheriff's Department is hosting the elected officials and Law Enforcement regarding Election Laws and concerning threats, etc. on Wednesday at their training facility.
- The Sheriff's Department has signed a contract with Hill Air Force Base to hold anyone they arrest at their facility. This may happen once to twice a year. It is not very common.
- The Sheriff's Department has received a reentry coalition grant from the BJA totaling 1.3 million regarding pursuing an innovative and collective pilot project to help with the opioid crisis. Commissioner Jenkins has asked that they not commit the money to anybody yet until they all attend a meeting to discuss what to do to help the homeless, reentry, etc. as the County has also received opioid settlement money. They want to figure out the best plan moving forward.

Commissioner Harvey made a motion to adjourn. Commissioner Jenkins seconded the motion. All say Aye. The motion carries.
