- 1. **APPROVE AN APPOINTMENT OF WEBER COUNTY COMMISSION CHAIR AND VICE CHAIR.**

Commissioner Harvey moved to appoint Commissioner Gage Froerer as Chair as Vice Chair for the Weber County Commission; Chair Bolos seconded.

Commissioner Froerer moved Commissioner James Harvey as Vice Chair for the Weber County Commission; Commissioner Bolos seconded.

2. **APPROVE RESOLUTION 01-2026 APPOINTING A TRUSTEE TO THE BOARD OF POWDER MOUNTAIN WATER & SEWER DISTRICT.**

Stacy Skeen (Commission Office): Robert Bingham is resigning from his Board position. Three applications were received from qualified candidates for the remainder of the term ending December 31<sup>st</sup>, 2028.

Commissioner Harvey moved to approve Resolution 01-2026 appointing Will Donovan to the Board of the Powder Mountain Water & Sewer District; Commissioner Bolos seconded.

3. **APPROVAL TO ADD A POSSIBLE COMMUNITY BLOCK GRANT PROJECT TO WEBER COUNTY’S CAPITAL IMPROVEMENTS FOR 2026-2030.**

Chad Meyerhoffer (Engineering): As part of the Community Development Block Grant process, the Weber Housing Authority needs a sponsorship from the County to receive Block Grant funding. Weber Housing asks Weber County be their sponsor for a grant for emergency rental and deposit assistance for low income households. The program will be used as prevention dollars to assist households remain stably housed rather than entering the homeless system. The funding would allow a one-time rental payment after the household has exhausted all of the resources and the household would be expected to participate in a budgeting class and must have the ability to pay the entire rent amount moving forward.

Commissioner Harvey moved to approve a possible Community Block Grant project to Weber County’s capital improvements for 2026-2030; Commissioner Bolos seconded.

4. **APPROVE AN AGREEMENT WITH PAM VICKREY FOR REPRESENTATION OF INDIGENT PERSONS IN THE SECOND DISTRICT JUVENILE COURT.**

Chris Crockett (Deputy Attorney): This is a standard contract we have used in the past.

Chair Froerer: I know serving on the Public Defender Board that this has been discussed with the judge and other board members.

Commissioner Bolos moved to approve an agreement with Pam Vickrey for representation of indigent persons in the Second District Juvenile Court; Commissioner Harvey seconded.

5. **APPROVE AN INTERLOCAL AGREEMENT WITH OGDEN VALLEY CITY FOR BUILDING PERMITTING AND INSPECTION SERVICES.**

Sean Wilkinson (Community Development Director): The County will furnish all of existing permitting and inspection services. There is no payment on this contract. The County will collect and remit the new city’s portion of their fee. And it falls on the City to make sure they meet the timeframes for review according to state code.

Commissioner Harvey moved to approve an Interlocal Agreement with Ogden Valley City for building permitting and inspection services; Commissioner Harvey seconded.

6. **APPROVE AN INTERLOCAL AGREEMENT WITH OGDEN VALLEY CITY FOR PLANNING SERVICES FOR APPROVED ADMINISTRATIVE ITEMS TO BE SEEN THROUGH TO COMPLETION.**

Sean Wilkinson (Community Development Director): This agreement is for approved projects already in work by the County. The agreement lists the projects to be completed at a rate of \$89 per hour.

Commissioner Bolos moved to approve an Interlocal Agreement with Ogden Valley City for planning services for approved administrative items to be seen through to completion; Commissioner Harvey seconded.

Sean Wilkinson (Community Development Director): This amendment changes the percentage of interest charged by the County if the city is late on payment. The change is from 12% to 6% and lasts for six months.
