2. **APPROVAL OF FIRST READING OF AN ORDINANCE OF THE COUNTY COMMISSIONERS OF WEBER COUNTY AMENDING PART OF SECTIONS 45, 16-2-12, AND 106-8-1; TO UPDATE REFERENCES IN THE COUNTY CODE TO MATCH THE NEWLY RENUMBERED TITLE 17, CLARIFY FINAL LOCAL ENTITY PLAT PROCESSING AND CORRECT SIGNATURE BLOCK LANGUAGE.**

Steve Collier (Surveyors Office): This ordinance makes minor adjustments to County code. First, references to state code will be updated following Title 17 rewrite that went into effect in November. Second, clarifying that final local entity plat reviews be done per page. Third, there is a correction to subdivision signature block call out.

Commissioner Harvey moved to approve First Reading of an Ordinance amending part of sections 45, 16-2-12, and 106-8-1; to update references in the county code to match the newly renumbered Title 17, clarify Final Local Entity Plat processing and correct signature block language; Commissioner Bolos seconded.
