B. PLEDGE OF ALLEGIANCE: All in attendance were invited to recite the Pledge.

D. COMMISSIONER COMMENTS:

1. Commissioner Harvey: The new AI coming to the Weber County Library with a system called Brainy. The system will help to advance learning in the County. Our libraries had a 10% attendance increase in 2025.

Duncan Olsen (GSEC Director): This is our first food festival and we do not have anything in our fee ordinance to cover this event.

2. Public hearing to take input on the compensation increases of certain executive county officers included in the 2026 Operating and Capital Budgets.

Steffani Ebert (County Comptroller): The 2026 approved budget included funding of 1.5% of each department's personnel budget to be allocated to employees in 2026 as part of the County's pay for performance program. We are required by state law to hold a public hearing prior to the adoption of our budget if the proposed budget includes compensation increases for executive county offices, which would be elected officials, department heads, chief deputies, division directors, and assistant directors. We held this hearing in November 2025 and presented the salary of each of these executive county officers with a pay for performance increase of 1.5%.

In the month of January, each of the elected officials and department heads and managers are tasked with evaluating their staff and allocating the budgeted funds to the employees, based on the employees' performance ratings. Because the public hearing we are required to have took place before these performance ratings were completed, there is a potential that these executive county officers may exceed the 1.5% that was estimated during the budget process.

We did have a couple of our departments award two executive county officers with proposed increases greater increase than 1.5%. Our personal property division administrator in the County Assessor's Office and our assistant human resources director were set to receive annual pay-for-performance increases of \$1716 and \$1683 and they are proposed to receive increases of \$2475 (2.15%) and \$1789 (1.60%).

USC 17-66-401 states that: Before a county legislative body may adopt a final budget or a final amended budget that includes a compensation increase for an executive county officer, the county legislative body shall:

- (i) hold a public hearing on the compensation increase;

Each of these employees' proposed increases are within the budget set for these departments, so no budget amendment is necessary. However, to make sure we are complying with state law, we are holding this public hearing due to the compensation increase for these two county officers being greater than what was previously presented.

In consultation with our County Attorney's Office, because we are not amending the budget, I don't believe any action is required on the part of the commission.

Jared Preisler (County Assessor): One of the employees is my employee. I am very much appreciative of this process. I wanted to remind the Commissioners in this particular role as our personal property director she actually functions in two areas. She represents us with MCAT and is responsible for the valuation of all the telecom in the state, not just in Weber County; Weber County gets compensated for that service. So part of her increase came from us evaluating her role and the revenue that is brought in directly from that MCAT contract. I just wanted to say thank you for the opportunity for following the process. We really appreciate her and her professionalism and representing the county and helping the entire state with the telecom valuations as well.
