- 1. **APPROVAL OF FINAL READING OF ORDINANCE 2026-01 OF THE COUNTY COMMISSIONERS OF WEBER COUNTY AMENDING PART OF SECTIONS 45, 16-2-12, AND 106-8-1; TO UPDATE REFERENCES IN THE COUNTY CODE TO MATCH THE NEWLY RENUMBERED TITLE 17, CLARIFY FINAL LOCAL ENTITY PLAT PROCESSING AND CORRECT SIGNATURE BLOCK LANGUAGE.**

Duncan Olsen (GSEC Director): This is the group that did the Dino Encounters last year at the Fair; it was one of the most liked events at the Fair. They have five different themes that travel around this contract is for their Ice Age Encounter featuring a large wooly mammoth. Attempts are being made to work with the Mammoth hockey team for some sponsorships and trades.
