1. CONTRACT WITH STIRRIN' DIRT RACING TO HOLD THE MAY MANIA DEMOLITION DERBY AT THE GOLDEN SPIKE EVENT CENTER.

Marty Smith (GSEC): One of our largest and best customers. Packaged costs in lieu of separate line item billing.

2. CONTRACT WITH ROY CITY TO ESTABLISH THE TERMS RELATED TO THE ROY CITY 6000 SOUTH PROJECT.

Brooke Stewart (Community Development): Roy City intends to purchase right of way in advance of construction of a roundabout at the intersection of 6000 South and 3100 West. Funding was recommended by WACOG and approved by the Commission as part of 2021 Transportation Priority List. Roy City is providing \$75K in matching funds and they received a CMAQ grant to construct the roundabout. This agreement establishes the terms for the Corridor Preservation Funds.

3. CONTRACT WITH WCG FOR OUR RIGHT OF WAY POOL.

Gary Myers (Engineering, Manager): Contract to employ WCG to buy Right of Ways as needed. WCG is one of five successful applicants selected to be part of the Right of Way pool.

4. CONTRACT WITH GRANITE CONSTRUCTION TO OVERLAY THE EXISTING ASPHALT AND IMPROVE GUARDRAILS AS NEEDED OVER THE NORTH OGDEN DIVIDE ROAD.

Ashley Thoman (Engineering): Two inch asphalt overlay and guardrail improvements along 4.5 miles stretch from North Ogden to 2900 East. \$1.4M contract with money set aside from Prop 1 funds last year; held off beginning until UDOT completed work. Performance grade asphalt covering temperature range of our area.

Commissioner Froerer moved for approval of contract with Granite Construction to overlay the existing asphalt and improve guardrails as needed over the North Ogden Divide Road pending required reviews form internal Weber County departments; Commissioner Froerer seconded.
