## 1. APPROVAL OF RESOLUTION 24-2022 APPOINTING A MEMBER TO THE OGDEN VALLEY PLANNING COMMISSION.

Rick Grover (Planning): One vacancy with two applicants. Will be filling Mr. Don Lewis remaining term.

Commissioner Froerer moved for approval Resolution 24-2022 appointing Dayson Johnson to the Ogden Valley Planning Commission; Commissioner Froerer seconded.

## 2. APPROVAL OF AN AGREEMENT WITH THE WEBER COMMUNITY FOUNDATION FOR THE COUNTY TO PROVIDE ADMINISTRATIVE SERVICES FOR THE FOUNDATION.

Scott Jenkins (County Commission Chair): Non-profit started by county to focal funds for non-profit money donated to the county. Director position not required at this time.

Chris Crockett (Attorney): Providing administrative support services (financial, accounting, legal, etc). Funds will reside with the County Treasurer.

Commissioner Froerer moved to approve an agreement with the Weber Community Foundation for the county to provide administrative services for the foundation; Commissioner Harvey seconded. Commissioner Froerer – aye; Commissioner Harvey – aye; Chair Jenkins – aye

# 3. APPROVAL OF GILMORE BELL FOR BOND COUNSEL ASSISTING IN THE REVIEW PROCESS OF A PETITION TO CREATE A PUBLIC INFRASTRUCTURE DISTRICT FOR THE SNOWBASIN DEVELOPMENT.

Chris Crockett (Attorney): Hiring outside counsel with specialized knowledge base required at times. Gilmore Bell will review PID petitions. Snow Basin to be billed; they have approved of this approach already.

Commissioner Harvey moved to approve Gilmore Bell for bond counsel assisting in the review process of a petition to create a public infrastructure district for the Snowbasin Development; Commissioner Froerer seconded.

# 4. APPROVAL OF CONTRACT EXTENSION WITH DAVIS COUNTY AND THE ECONOMIC DEVELOPMENT CORPORATION OF UTAH FOR A REGIONAL ECONOMIC DEVELOPMENT MANAGER.

Gage Froerer (Commissioner): Three years ago agreement was entered with EDC of Utah. Collaborative effort. Original contract was for 5 years with option to extend at the 3 year mark. Davis County approved the same extension. Recommend approval of extension.

Commissioner Harvey: Started this process five years ago with canvassing local businesses.

Chair Jenkins: This has been a wonderful effort.

Commissioner Harvey moved to approve a contract extension with Davis County and the Economic Development Corporation of Utah for a regional economic development manager; Commissioner Froerer seconded.

# 5. APPROVAL OF A PROFESSIONAL SERVICES AGREEMENT WITH THE WEBER COUNTY ATTORNEY'S OFFICE AND THE UNIVERSITY OF UTAH, DEPARTMENT OF PEDIATRICS FOR EXPERT WITNESS SERVICES IN A PENDING CRIMINAL MATTER.

Chris Crockett (Attorney): Agreement for prosecutors to hire an expert witness; in this case, a pediatric doctor, Dr. Antoinette Laskey. Signature line is for County attorney approval, requiring specific allowance from the Commissioners to sign on their behalf.

Commissioner Harvey moved to approve a Professional Services Agreement with the University of Utah, Department of Pediatrics for expert witness services in a pending criminal matter, with Attorney's office given authority to sign the agreement; Commissioner Froerer seconded.

2. Public Hearing for consideration of a county initiated text amendment, amending the Ogden Valley Stream Corridor Setbacks for certain subdivided lots.

Steve Burton (Planning): Ordinance adopted in 2005 with no exemption for lots with buildable envelopes or previous stream setback. Proposing to exempt lots that were platted prior to 2005 Ordinance approval as long as they address the stream in some way. Ogden Valley Planning Commission recommended approval of this proposal on November 30<sup>th</sup>, 2021. Planning staff recommends approval.

Chair Jenkins: How does the septic system relate to the setbacks?

Mr. Burton: Our land use code does not cover those regulations. That is covered by Health

Department. This change does not allow drain fields to be closer to streams.

Rick Grover: This will help alleviate the number of cases brought to the Board of Adjustment.

Approximately 15 such cases brought to the board the past few years. Could be 40-

50 more potentially impacted.
