### **G.** ACTION ITEMS:

1. APPROVAL OF AN INTER-LOCAL AGREEMENT BY AND BETWEEN WEBER COUNTY AND THE MARRIOTT-SLATERVILLE COMMUNITY REINVESTMENT AGENCY TO REBATE 60% OF NEW TAXES COLLECTED, UP TO \$1.5 MILLION OVER THE NEXT 15 YEARS.

Roger Brunker shared that everything is in order for the interlocal agreement.

Commissioner Froerer has concerns about affordable housing plan and how to encourage cities to implement such housing when economic development pursued. Will support approval when affordable housing plan provided.

Commissioner Jenkins moved to approve the Inter-local Cooperation Agreement with Marriott-Slaterville Community Reinvestment Agency to rebate 60% of new taxes collected, up to \$1.5 million over the next 15 years with the added requirement that an Affordable Housing Plan be provided; Commissioner Froerer seconded with comment that the affordable housing plan needs details related to zoning, multi-family housing/entry-level housing, and details going beyond 10% requirement; await signing for plan.

Resolution will be brought back for vote later and interlocal voted on today.

2. Public hearing to consider and take action on a request to vacate 7 foot public utility easements, located along the west and north boundaries of lot 7, Willow Greene Estates Phase 1 Subdivision.

Tammy Aydelotte (Planning) described the following:

- Property in question is located in R2 zone in Willow Greene Estates.
- Current setbacks for property being 20' in front, 8' and 10' for the side yards, 1' in the back yard for an accessory building.
- Applicants want a shed against corner of boundary lines but currently cannot due to a 7' easement straddled on either side.
  - o They request vacating the west and north easements.
- However, County has infrastructure along western boundary (storm drain line, no manhole cover).
- Planning recommends only vacating the north easement.
