## 1. CANVAS FOR THE 2025 PRIMARY ELECTION

## A. MOTION TO ADJOURN THE PUBLIC MEETING AND CONVENE A MEETING OF THE **BOARD OF CANVASSERS.**

Commissioner Harvey moved to adjourn the public meeting and convene as a Board of Canvassers, 10:07 a.m.; Commissioner Froerer seconded. County Treasurer Lynelle Jensen joined the Board of Canvassers in the absence of Chair Bolos, as required per Utah State Code. ## B. BOARD OF CANVASSERS- CERTIFY THE RESULTS OF THE 2025 PRIMARY ELECTION.

Lauren Shafer (Elections Director): Only Ogden Valley City will be canvassed today as the other municipalities canvassed their elections. There were 4,895 registered voters with 2,983 ballots counted and only 31 rejected; this resulted in a 60.9% turnout which is high for a municipal election. 16 provisional ballots were cast with two rejections due to the form not being completed. 5,197 ballots

were mailed to voters and 3,014 were cast, which accounts for the 31 rejected. There were 2,183 ballots not returned and 166 were undeliverable ballots. Of the rejected ballots, 25 were returned past the deadline, two had signatures not matching what was on records, one that was unsigned, and one that was signed by someone other than the voter.

# 6. APPROVE A CONTRACTOR AGREEMENT WITH WEBER-MORGAN HEALTH DEPARTMENT FOR USE OF OPIOID LITIGATION SETTLEMENT FUNDS.

Chris Crockett (Lead Civil Attorney): This agreement will grant approximately \$180k to the Weber-Morgan Health Department for one year using settlement funds obtained through litigation with various opioid manufacturers and distributors.

Bryce Sherwood (Weber-Morgan Health Department, Community Health Director): These funds will be used to increase what we are already doing, not to supplant current efforts.

Commissioner Harvey moved to approve Contractor Agreement with Weber-Morgan Health Department for use of Opioid Litigation Settlement Funds; Commissioner Freorer seconded. Chair Bolos – excused; Commissioner Freorer – aye; Commissioner Harvey - aye
