2. APPROVE A LOCAL TRANSPORTATION FUNDING AGREEMENT WITH OGDEN CITY FOR THE OGDEN 20TH STREET (PHASE 3) PROJECT.

Brooke Stewart (Community Development): The Local Transportation funding agreement is for the 3rd and final phase of the Ogden City 20th Street project. With this project Ogden City intends to widen and improve just under half a mile from Quincy Avenue to a couple hundred feet east of the Harrison Blvd intersection. The project will be completed in part with local matching funds from Ogden City, a Surface Transportation Fund grant and the 3rd quarter cent sales tax funds. The project was recommended from funding by WACOG and approved by the County Commission as part of the 2021 Transportation priority list. The agreement outlines the terms related to the sales tax funds that are programmed for 2024. All concerns raised earlier have been addressed.
