 1. Commissioner Froerer: I wanted to give a brief history of MIDA (Military Installation Development Authority). MIDA was created through the state legislature in 2007 and was intended to generate tax dollars to be passed on to Federal installations. Falcon Hill employs about 7k people who all make above the average AMI (Area Median Income). A 1.5M square foot manufacturing and office space is 100% occupied with about 20% of the total project completed. Snow Basin had a lodge used by the military. When the Olympics came in, an agreement was made for that lodge to go private with the contingency that another location would be set aside for a new lodge with land eventually secured in Deer Valley. Last year, the Grand Hyatt opened there and offers military personnel substantially reduced rates. It created a \$6.5B investment and \$2.5B increase in property values on a project that is 20% complete. MIDA donated \$50k to Weber County and to each of the four surrounding cities and \$100k to Hill AFB Museum with money from the tax base MIDA created at Falcon Hill Hill.

Lauren Shafer (Elections Director): Today we are canvassing for Ogden Valley City as the other municipalities are canvassing their own races. The following are results for Ogden Valley City elections:

- Ballot Dispositions:
 - Voter Turnout: A high 70.26% of registered voters participated.
 - Ballots Counted: 3,473 ballots were counted out of 5,046 mailed.
 - 21 Provisional ballots
 - 18 were failed due to insufficient ID
 - Rejected Ballots: 95 ballots were not counted
 - 88 ballots were returned too late.
 - 2 did not have signatures that matched their record
 - 2 were signed by someone other than the voter
 - 1 had an unsigned envelope
 - 1 had an empty envelope
 - 1 ballot was returned without an envelope

 - Council Seat 1: Tia V. Shaw (377 votes)

Commissioner Froerer: Three years ago we received a substantial amount of money from the federal government through ARPA. Because we were so conservative with those funds and held those groups who received funds accountable we ended up with some left over. That money has to be spent by the end of 2026. Due to the delay in funding for SNAP funds, I feel it would be appropriate to share up to \$50k of those leftover funds with the Catholic Community and TriCity food banks.

I will already be in attendance and Commissioner Froerer is willing to be the alternate.
