

2. Public Hearing to take input on the operating and capital budgets of Weber County for the 2026 calendar year.

Steffani Ebert (County Comptroller): Our budget process started in August. Weber County is not proposing any tax increases for 2026. Most of the county's money comes from property taxes and sales taxes, but the county only keeps a small part (about 16-18%) of the total property tax collected. The General Fund (which pays for things like public safety and general services) spends the largest amount (69%) on employee pay

and benefits. There is a near term challenge with the paramedic services fund, which is expected to have a \$1.2 million shortage in 2026. County savings will be used to cover it for now but will need to review the issue next year. Capital project plans include fixing up existing buildings like the Weber Center and working on the expansion of the medical facility at the jail. The County will add two part-time staff in the County Attorney's Office and an outreach coordinator at the animal shelter.

County Budget and Employee Compensation details: (See presentation below)



Public Comment: None.

Commissioner Harvey: If anyone has questions related to tonight's budget presentation, please feel free to contact any of the Commissioners. I want to compliment our staff. While many of the surrounding counties have increases of 20-30%, our staff made necessary reductions to absorb the compensation increases. I am grateful for them. I appreciate our first responders. We will follow the results of the compensation study and remain fair with our compensation. Our Sheriff has been very supportive of the three Commissioners during this study.

Chair Bolos: The added Animal Control position is paid out of a separate fund outside of the General Fund. The additional amount requested by the Sheriff was \$700k but our HR Director felt strongly further adjustments should be made resulting in more than double the requested amount. To meet a portion of that increase, the Sheriff's department came up with over \$300k in savings. Instead of a tax increase, our Commissioners prioritized our employees over moving money over to Capital budgets as in prior years.

3. Public hearing to take input on compensation increases of executive county officers included in the 2026 Operating and Capital Budgets. Pursuant to UCA §17-66-401.

Steffani Ebert (County Comptroller): State statute requires a public hearing for any increases to salaries for County elected and executive officials. Elected officials are proposed to receive a 3% pay increase. Other executive officers will receive increases based on results of the compensation study, which will be 3.5% for most and higher for anyone who's current pay was found to be below market average. Public Comment:

- 1. John Arrington, North Ogden City: I just wanted to make sure I was reading the compensation study correctly. Looks like the first two columns are current compensation and the rest are the proposed market adjustments? I understand the law enforcement increases. I just wanted that clarified, thank you.
 - a. Chair Bolos: Correct

Commissioner Froerer: Some in the public feel our employees are being overpaid compared to private sector. I feel the results of the compensation study and seeing good employees leave for higher paying jobs justify the pay being offered by Weber County.

Commissioner Harvey: We are very fortunate to have the team we do that makes it possible for our County to be viewed as being in the top 2% of counties in the country.

Chair Bolos: There are several websites that have information on public compensation; Weber County compensation is reported to transparent.utah.gov.
