Weber County – 12th Street Corridor, Segment 4 Change Order 3

Weber Basin Water Conservancy District (WBWCD) has requested the contractor to add cathodic protection for 5 connection points along the new culinary waterline. WBWCD provided the contractor with a set of details for the cathodic protection needed. This change order is to cover the costs of the added scope of including cathodic protection to the culinary waterline installation.

The following items are being added to the contract.

Add Item: 81 Cathodic Protection for WBWCD

(81 – Cathodic Protection for WBWCD) At the request and direction from WBWCD the contractor will install cathodic protection at the 5 remaining connections as part of the culinary waterline installation. This pay item is to cover all the labor, materials and equipment necessary to provide the cathodic protection at these 5 locations. The contractor has submitted a lump sum price of \$45,725.00 to install the cathodic protection. The contractor's cost is shown in Exhibit A. The contractor's costs were sent to WBWCD for review and approval. WBWCD approved the pricing as it is in line with similar culinary waterline installation projects. The WBWCD email approval is shown in Exhibit B.

Staker Parson submitted a cost for each item as follows:
