

Kassi Bybee, also known as "Ogden Eccles Conference Center," agrees to hire **Hana Entertainment**, henceforth known as "Artists," for a performance at/for **343 E 25th St, Ogden, UT 84401** on **September 11th, 2024**.

The two parties agree to the following:

Artist/s will provide **Singers & Ukulele Players** providing music only, at the above specified location & date, for a period of **60 mins** beginning at **5:45pm**, followed by **high energy traditional drumming** for **30 mins** at **7:00pm**, and ending with a **full 1 hour show** starting at **7:30pm** for **\$7,850.00**.


The performance will specifically consist of:

- **Hana Custom Package: \$7,850.00**
- Audience Participation: **INCLUDED**
- Sound system: **Provided by Ogden Amphitheater with AV personnel**
- All microphones & mic stands will be provided by **Hana Entertainment**.
- The client will provide leis, prizes for the competition, and poi for eating.

Ogden Eccles Conference Center will pay artists **\$7,850.00** (before CC Fee) as compensation for this performance, payable via online e-mail invoice and according to the following plan: **There is a deposit of 50% is due upon receipt of the initial invoice. The remaining 50% will be due the day of the performance.**

Setup for the performance will be the responsibility of **Hana Entertainment & Ogden Eccles Conference Center. Ogden Eccles Conference Center is responsible for a safe location for the performance & Ogden Eccles Conference Center is responsible for a dressing area & restrooms for your dancers. Hana Entertainment is responsible for cleaning up their trash & safety protocol.**

If Ogden Eccles Conference Center cancels the performance with less than **2 weeks** of performance, he/she will pay Artist 80% of original agreement price. Last minute date-change requests (72 prior) will add an additional 20% of the original amount, if the new requested date is available. The minimum booking fee of \$100.00 is non-refundable. Artist may cancel the performance **if contract is breached or deposit hasn't been paid in advance. Any changes to the time or lineup day of show will have an additional fee of \$200. If full amount is not paid by the day of, an additional fee of \$20 per day of nonpayment will accrue.** *This performance will be filled based on performers availability and may or may not include Joseph Cancilla at the performance.* This contract is enforceable according to the laws and regulations of the state of **Utah**.
