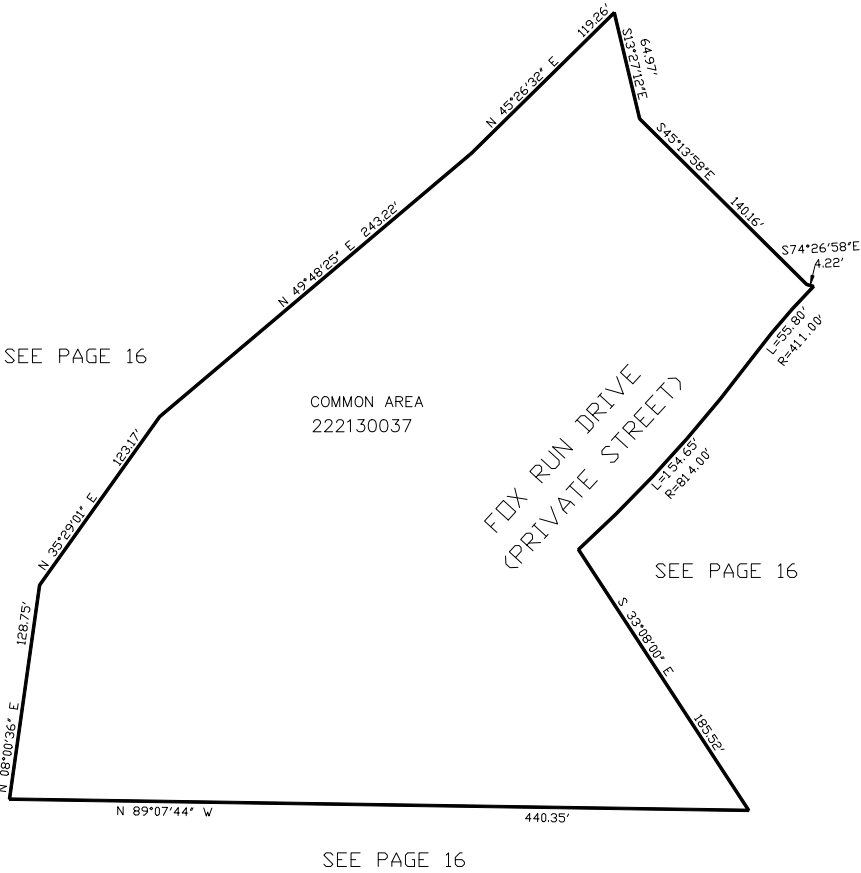


PART OF THE SW.1/4, OF SECTION 22, T.7N., R.1E., S.L.B. & M.
