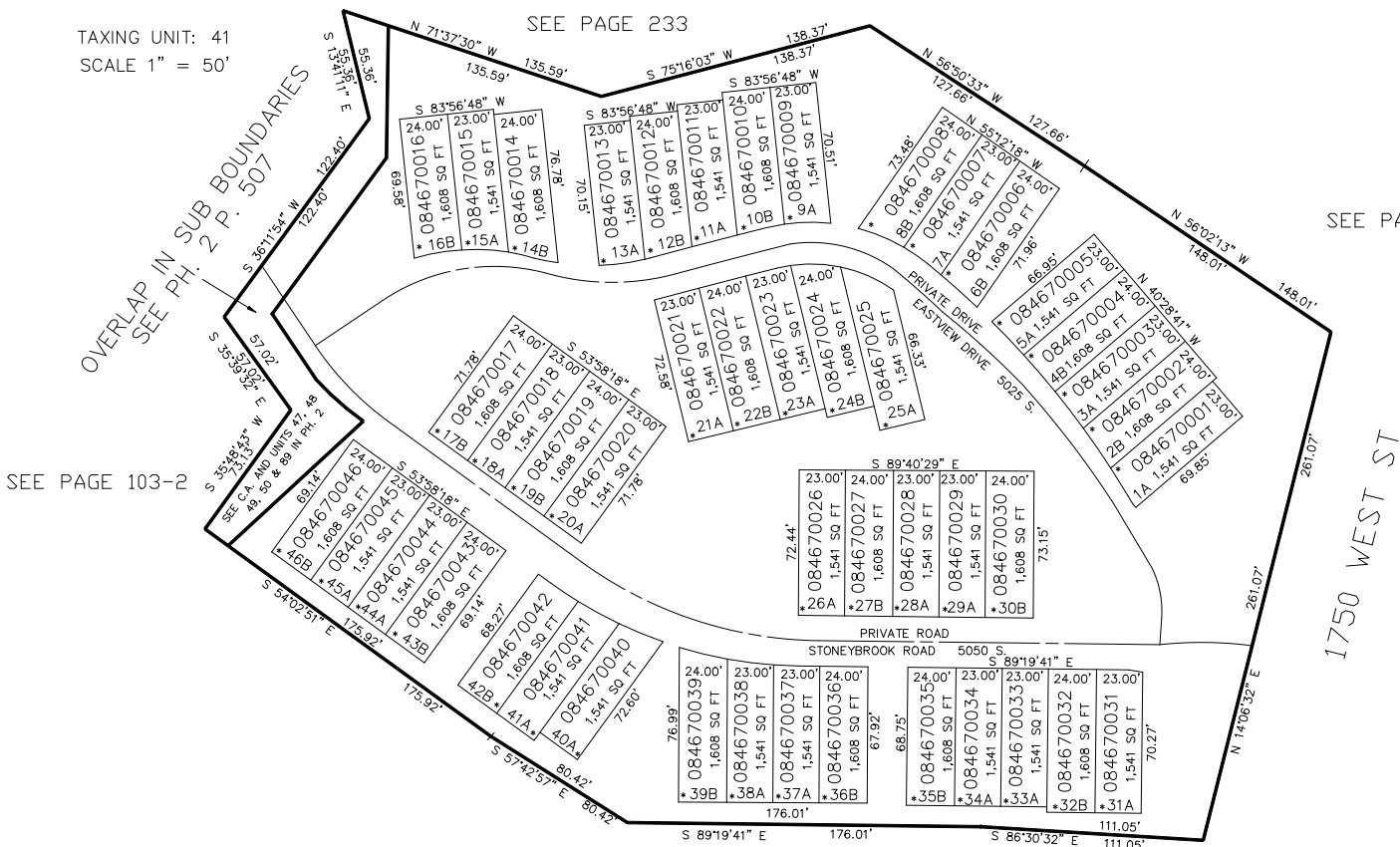


PART OF THE NW.1/4, OF SECTION 13, T.5N., R.2W., S.L.B. & M.
