NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO DEFINE THE BASIN LAND AND LIVESTOCK PROPERTY FOR BONNEVILLE RANCHES. CAUSEY ESTATE SUBDIVISION AND JACOBS PROPERTY WERE DETERMINED FROM A BEST FIT OF THE FOUND MONUMENTS. THE WEST LINE OF THE JACOBS PROPERTY WAS DETERMINED BY THE CLIENT. THE LINE ALONG THE SOUTH LINE OF THE STEVEN E. LINDQUIST AND PAUL A. JOHNSON WAS FIXED AS A FENCE BY THE CLIENT. WITH FENCE LINE AGREEMENTS. THE NORTH LINE OF THE DAVID C. WILDE PROPERTY WAS FIXED BY A FENCE. THE OVERALL BOUNDARY OF THE PROPERTY WAS DETERMINED BY THE FOUND SECTION CORNERS AND RECORDED DATA. IN TOWNSHIP 6N., R.2E. AND IN THE CAUSEY ESTATES AREA WE FOUND WEBER COUNTY MONUMENTS THAT FIT WELL WITH THE ORIGINAL STONES. IN ALL AREAS THE RELATIONSHIP BETWEEN THE FOUND STONES AND THE RECORD DATA WAS FOUND TO BE VERY CLOSE. THE STONES WERE FOUND TO BE MARKED CONSISTENTLY WITH FEDERAL GUIDELINES.
