

## Narrative

THE PURPOSE OF THIS SURVEY IS TO CREATE A RECORD OF SURVEY OF JOHN A. DOWNS PROPERTY IN OGDEN CITY, WEBER COUNTY, UTAH FOR MIKE LUNT CONSTRUCTION. THE WEST LINE WAS FIXED BY THE WEST LINE OF LOT 7 OF DOWNS SUBDIVISION NO.1. THE NORTH LINE WAS FIXED BY THE NORTH LINE OF SAID LOT 7. THE EAST LINE WAS FIXED BY THE EAST BOUNDARY LINE OF SAID SUBDIVISION. THE SOUTH LINE WAS DETERMINED BY DEED. THE MOST SOUTHERLY LINE WAS FIXED BY THE MOST SOUTHERLY LINE OF SAID LOT 7. THE SOUTHWESTERLY CORNER WAS FOUND AS SHOWN HEREON. ALL OTHER PROPERTY CORNERS WERE SET AS SHOWN HEREON.

## Basis of Bearings

THE BASIS OF BEARINGS FOR THIS SURVEY IS THE PLAT OF DOWNS SUBDIVISION NO. 1 IN THE CITY OF OGDEN, WEBER COUNTY, UTAH, DETERMINED LOCALLY BY THE MONUMENT LINE BETWEEN THE INTERSECTION OF 7TH AND DOWNS AND THE INTERSECTION OF 7TH AND WALL. SHOWN HERE AS S89°09'46"E

BEGINNING AT A POINT WHICH IS \$89\*09'46"E 116.71 FEET ALONG THE CENTERLINE OF 7TH STREET AND NORTH 590.55 FEET FROM THE CENTERLINE MONUMENT OF 7TH STREET AND DOWNS STREET; THENCE N89\*02'00"W 36.02 FEET; THENCE \$47\*13'25"W 103.05 FEET; TO A 50.00 FOOT RADIUS CURVE; THENCE NORTHWESTERLY ALONG SAID CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 43\*40'41" A DISTANCE OF 38.12 FEET. THE CHORD BEARS N64\*36'56"W 37.20 FEET; THENCE N03\*32'44"E 90.44 FEET; THENCE \$88\*18'20"E 44.79 FEET; THENCE \$89\*25'20"E 95.58 FEET; THENCE \$01\*06'53"W 34.56 FEET; TO THE POINT OF BEGINNING:
