NARRATIVE

This Property survey was requested by Mr. Robert Favero of the L.D.S. Church for the purpose of establishing the boundaries, providing revised overall descriptions and determining the acreage of this property. Brass Cap Monuments were found at the Northeast Corner, the North 1/4 Corner, the Northwest corner, the Southwest corner, the South 1/4 corner and the Southeast corner of Section 24, T6N, R1E, SLB&M. A Line bearing S 89"36'57" E between the Brass Cap Monuments found at the Northwest corner and the North 1/4 corner was used as the basis. of bearings. The North-South 1/4 Section line in Section 19, was established at a point 2640 feet West of the East Corners of the Section. The East-West 1/4 Section line in Section 24 was established using the North line of the Proposed The Legends @ Hawkins Creek development and the South line of The Summit at Ski Lake Developments. Trappers Loop Road was established on the ground as it related to the fences, right of way monuments were found along Trappers Loop but were not able to be checked. State Highway U-39 was established on the ground as it related to the existing right of way monuments. No Property corners were not set at this time.


