### **BOUNDARY DESCRIPTION**

PART OF THE SOUTHEAST QUARTER OF SECTION 26, TOWNSHIP 7 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY: BEGINNING AT A POINT 901.345 FEET NORTH AND 590.38 FEET, MORE OR LESS, WEST FROM THE SOUTHEAST CORNER OF SAID QUARTER SECTION, SAID POINT BEING THE EAST LINE OF THE COUNTY ROAD, RUNNING THENCE SOUTH 0"15" EAST 350.71 FEET ALONG SAID EAST LINE, THENCE SOUTH 89"32"28" EAST 122 FEET, THENCE NORTH 0"15" WEST 24 FEET, THENCE SOUTH 89"36"23" EAST 80.02 FEET TO EXISTING RIGHT OF WAY FENCE OF INTERSTATE 15, THENCE NORTHERLY ALONG SAID RIGHT OF WAY FENCE 330.80 FEET MORE OR LESS TO A POINT SOUTH 89'36'23" EAST 239.89 FEET FROM THE POINT OF BEGINNING, RUNNING THENCE NORTH 89'36'23" WEST 239.89 FEET TO THE POINT OF BEGINNING.


#### **NARRATIVE**

EPIC ENGINEERING WAS HIRED TO PERFORM AN BOUNDARY SURVEY FOR THE FAR WEST SURGICAL CENTER, IN SECTION 26, TOWNSHIP 7 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN. EPIC FOUND AND USED REBAR'S AND CAPS SET FROM TWO RECORDS OF SURVEY, ONE BEING DONE BY GREAT BASIN ENGINEERING FILED IN THE WEBER COUNTY SURVEYOR'S OFFICE AS SURVEY NUMBER 000215, THE OTHER WAS FILED BY HANSEN AND ASSOCIATES IN THE SAME OFFICE AS SURVEY NUMBER 003264. EPIC ALSO FOUND TWO RIGHT OF WAY MONUMENTS THAT DEFINED THE EAST LINE OF SAID PROPERTY. THE NORTH LINE WAS ESTABLISHED USING THE RECORD OF SURVEY DONE BY HANSEN AND ASSOCIATES THE. WEST LINE WAS ESTABLISHED USING ONE OF THE REBAR'S SET BY GREAT BASIN AND THE RIGHT OF FENCE FOR STATE ROAD 89. ON THE SOUTH LINE THERE IS A 13 FOOT GAP BETWEEN THE DEEDS FOR CHUGG ENTERPRISE FILED IN THE WEBER COUNTY RECORDS OFFICE AS ENTRY NUMBER 2039905 AND THE DEED FOR MICHAEL D. VAUSE AND NANCY L. VAUSE FILED IN THE SAME OFFICE AS ENTRY NUMBER 1088143. EPIC WOULD RECOMMEND THAT THERE WOULD BE A BOUNDARY LINE AGREEMENT FILED TO CLEAR UP THIS ISSUE.


