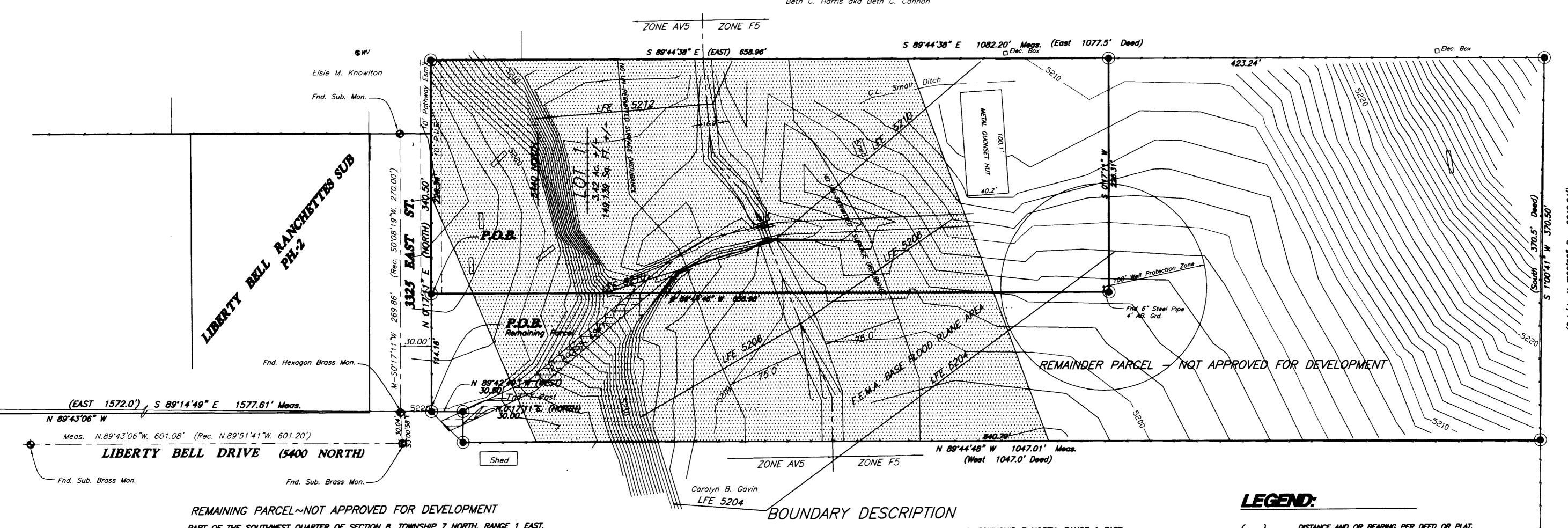

THE REQUEST FOR THIS SURVEY WAS TO SURVEY THE BOUNDARY OF TAX I.D. No. 22-005-0013 PER THE WEBER COUNTY RECORDS.

BASIS OF BEARINGS USED ARE STATE PLANE GRID OF N.0'45'11"E. ALONG THE AS MONUMENTED WEST SECTION LINE OF THE SOUTHWEST QUARTER OF SECTION 8, TOWNSHIP 7 NORTH, RANGE I EAST, SALT LAKE BASE AND MERIDIAN, MONUMENTED BY WEBER COUNTY

SURVEYORS BRASS CAP MONUMENTS. THE SOUTHWEST CORNER OF SAID SECTION 8, HAS HAD THREE KNOWN MONUMENTED LOCATIONS IN THE PAST. THE MOST CURRENT MONUMENTED LOCATION IS THE ONE USED FOR THIS SURVEY, MONUMENT DATED 1998 (1999 ON CURRENT TIE SHEET).

A RETRACMENT OF LIBERTY BELL RANCHETTES SUBDIVISION—PHASE 2 HAS IDENTIFIED 3325
EAST STREET, AND THEREBY ALSO THE EASTERN BOUNDARY OF SAID SUBDIVISION, WHICH
MATCHES THE WESTERN BOUNDARY OF THIS PARCEL OF THE PARCEL OF THE EASTERN BOUNDARY HAS CALLED FOR, ALONG AN THISTING FENCE, SAID FENCE LINE HAD A COUPLE OF SMALL ANGLE POINTS. USING THE NE FENCE CORNER AND THE (SE CORNER) FENCE INTERSECTION ALLOWED THE CLOSING OF THIS PROPERTIES DEED CALLS TO
