Basis of Bearings

THE BASIS OF BEARINGS FOR THIS PLAT IS THE CENTERLINE BETWEEN A FOUND CENTERLINE MONUMENT AT THE INTERSECTION OF 17TH STREET AND GIBSON AVENUE AND A FOUND CENTERLINE MONUMENT AT THE INTERSECTION OF 17TH STREET AND CENTER AVENUE. SHOWN HEREON AS N89'02'00"W

Narrative

THE PURPOSE OF THIS SURVEY WAS TO REESTABLISH THE BOUNDARY OF THE BELOW DESCRIBED PARCELS OF LAND. SOME DISCREPANCIES EXISTED IN THE ACTUAL LOCATION OF THE OREGON SHORTLINE RAILWAY CO. PARCEL DUE TO THE DIFFICULTY IN READING AND DECIPHERING THE ORIGINAL QUITCLAIM DEED WHICH WAS RECORDED ON JUNE 30 1880 IN BOOK "N" ON PAGE 52. THIS QUITCLAIM DEED IS BETWEEN SAMUEL GLASGOW AND THE UTAH & NORTHERN RAILWAY COMPANY, PREDECESSOR TO UNION PACIFIC RAILROAD COMPANY, DATED NOVEMBER 26, 1897.

THE WEST BOUNDARY LINE WAS FIXED BY THE EAST SIDE OF CENTER AVENUE. THE NORTH LINE OF PARCEL "A" AND THE RAILROAD RIGHT OF WAY WAS ESTABLISHED BY ADJOINING DEEDS WHICH ARE IN HARMONY WITH THE ROAD RIGHT OF WAY'S AND THE 66 FOOT DISTANCE FOR SAID RIGHT OF WAY. THE SOUTH LINE WAS FIXED BY DEED. ALL BOUNDARY CORNERS WERE SET WITH A 5/4" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES" UNLESS NOTED.

BEGINNING AT A POINT ON THE EAST RIGHT OF WAY LINE OF CENTER AVENUE WHICH LIES S00'58'00"W 779.23 FEET AND EAST 24.75 FEET FROM A FOUND CENTERLINE MONUMENT IN THE INTERSECTION OF 17TH STREET AND CENTER AVENUE; THENCE NO0'58'00"E ALONG SAID EAST RIGHT OF WAY LINE 291.73 FEET TO THE SOUTH LINE OF THE OREGON SHORTLINE RAILWAY CO.; THENCE S46'58'00"E ALONG SAID SOUTH LINE 354.89 FEET; THENCE WEST 120.00 FEET; THENCE SOUTH 49.50 FEET; THENCE WEST 144.33 FEET TO THE POINT OF BEGINNING;
