

PARCEL DESCRIPTION

BEING A PART OF THE SOUTHWEST OUARTER OF SECTION 5, TOWNSHIP 5 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE SOUTH LINE OF SAID SECTION 5, SAID POINT BEING S.89°34'03"E.. ALONG THE MONUMENTED SECTION LINE, 1369.65 FEET FROM THE SOUTHWEST CORNER OF SAID SECTION 5, AND RUNNING:

THENCE N.10°51'27"E., PASSING THE SOUTHEAST CORNER OF THE HAROLD BRENT ANDERSON AND SUZANNE P. ANDERSON PARCEL AS DESCRIBED IN BOOK 891, AT PAGE 166, OF THE DEED RECORDS OF WEBER COUNTY, UTAH. AND CONTINUING ALONG THE EAST LINE OF SAID PARCEL FOR A TOTAL OF 328.00 FEET TO AN ANGLE POINT IN SAID LINE;

THENCE N.18°46'57"E., 320.00 FEET TO THE NORTHEAST CORNER OF SAID ANDERSON PARCEL;

THENCE N.89°34'03"W., 94.00 FEET TO THE NORTHWEST CORNER OF SAID ANDERSON PARCEL:

THENCE N.19°28'17"E., 566.39 FEET TO A POINT ON THE WEST BANK OF THE NORTH BRANCH OF THE WILSON CANAL;

THENCE S.70°35'33"E., 78.82 FEET TO THE CENTER OF A 15" UNDERGROUND IRRIGATION LINE;

NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY WAS TO DELINEATE THE LINE OF THE SURVEYED PROPERTY ON THE GROUND. FOR NEW OWNERS. THE 15" BURIED IRRIGATION LINE ALONG THE NORTH WAS SURVEYED BY WAYNE CROW, WHEN THIS PARCEL WAS SEPARATED FROM THE PARENT PARCEL. THE HAROLD B. ANDERSON PARCEL WAS RETRACED, WITH ONLY A DEED ROTATION REQUIRED FOR SAME. HOWEVER. WHO OR WHATEVER PERSON ORIGINALLY SURVEYED THE ANDERSON PARCEL AS MENTIONED IN DESCRIPTION, CALLED FOR THE WEST BANK OF THE WILSON CANAL. ACTUALLY THEY MISTOOK A SLOUGH FOR A CANAL. AND THE LINE RUNS ALONG THE EAST BERM OF THE FILL OVER THE COVERED PORTION OF A BRANCH OF THE HOOPER CANAL. THE WILSON CANAL LIES WESTERLY OF THE HOOPER CANAL AS SHOWN.
