

PART OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 6 NORTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY: BEGINNING AT A PDINT WHICH IS NORTH 0°14'22" WEST 1138.00 FEET ALONG THE SECTION LINE AND NORTH 89\*52'04" EAST 1485.24 FEET FROM THE WEST QUARTER CORNER OF SAID SECTION 15 (SAID POINT BEING NORTH 89°52'04" EAST (N89°37'42"E RECORD) 368.33 FEET FROM THE NORTHWEST CORNER OF LOT 3, SOUTH FORK RANCHETTES SUBDIVISION) RUNNING THENCE NORTH 00°11'53" EAST 284.26 FEET ALONG THE EAST LINE OF THE RICHARD E. WARD AND DENISE E. KNIGHT PROPERTY TO THE SOUTH RIGHT-OF-WAY LINE OF HIGHWAY 39; THENCE NORTH 89\*05'27" EAST 817.20 FEET ALONG SAID SOUTH RIGHT-OF-WAY LINE TO THE NORTHWEST CORNER OF THE GEORGE PAPPAS JR. PROPERTY; THENCE ALONG SAID WEST LINE OF GEORGE PAPPAS PROPERTY SOUTH 00°08'28' EAST 295.33 FEET TO THE NORTH LINE OF THE SOUTH FORK RANCHETTES SUBDIVISION; THENCE SOUTH 89°52'04" WEST 818.81 FEET ALONG SAID NORTH LINE TO THE POINT OF BEGINNING CONTAINS 5.44 ACRES

THE PURPOSE OF THIS SURVEY WAS TO CREATE A ONE (1) LOT SUBDIVISION AS SHOWN. BASIS OF BEARING IS UTAH STATE PLANE GRID BEARING AS SHOWN. THE BEARING ON SOUTH FORK RANCHETTES NORTH LINE IS ROTATED TO STATE PLANE GRID BEARING.
USING A ROTATED BEARING OF 0°14'22' TO THE RIGHT FITS
EVERY FENCE LOCATED IN THIS AREA. USING A ROTATED BEARING TO THE LEFT DOES NOT MATCH ANY OCCUPATION OR THE HIGHWAY 39 RIGHT OF WAY PHYSICAL LOCATION AND THE RIGHT OF WAY MARKERS.
