This survey was completed using Title Report File No. 120530 dated July 25, 2007 from Old RepublicNational Title Insuracne Company.






### Flood Plain Data

# Record Description


A part of the Northeast Quarter of Section 32, Township 7 North, Range 1 West of the Salt Lake Base and Meridian.
