
Title Information

Parcel 1:

All of that portion of the following described property lying Westerly of the Roy Water Conservancy Subdistrict Line.

Narrative

This Survey was requested by Mr. John Thomas of Soleco, Inc. prerequisite to development of this property.

A line between monuments found for South Quarter Corner and the Southeast Corner of Section 3 was assigned the Weber County Survey Bearing of S 89°25'05" E as the Basis of Bearings.

The alignment of the Layton Canal as shown on this survey is from field location as it exists on the ground and as it affects the entire length of this half section.

No Property Corners were placed with this Survey.

Flood Plain Data

This property lies entirely within Flood Zone X as designated on FEMA Flood Insurance Rate Map for Weber County, Utah and Incorporated Areas Map Number 49057C0425 E dated 16 Dec. 2005. Flood Zone X is defined as "Areas determined to be outside 500-year floodplain." (no shading)




