

BEGINNING AT THE SOUTHWEST CORNER OF SAID SUBDIVISION SAID POINT BEING ON THE EAST RIGHT—OF—WAY LINE OF LINCOLN AVENUE LOCATED NORTH 90°00'00" EAST 421.03 FEET AND NORTH 00°00'00" EAST 73.89 FEET FROM THE SOUTHWEST CORNER OF SAID LOT 23; RUNNING THENCE NORTH 00°58'00" EAST 60.00 FEET TO THE SOUTH LINE OF LOT 7 LINCOLN PROPERTIES SUBDIVISION; THENCE ALONG SAID SOUTH LINE OF SAID LOT 7 THE FOLLOWING THREE (3) COURSES: (1) SOUTH 89°02'10" EAST 25.00 FEET; (2) NORTH 80°08'00" EAST 45.75 FEET; (3) SOUTH 71°58'36" EAST 27.56 FEET; THENCE SOUTH 00°58'00" WEST 58.03 FEET TO THE SOUTH LINE OF SAID SUBDIVISION; THENCE ALONG SAID SOUTH LINE THE FOLLOWING TWO (2) COURSES: (1) SOUTH 88°58'15" WEST 71.32 FEET; (2) NORTH 89°02'10" WEST 25.00 FEET TO THE POINT OF BEGINNING. ## Narrative

The purpose of this survey was to establish and set the property corners of the parcel as shown and described hereon. The survey was ordered by Joe Dunn. The control used to establish the property corners was the existing original survey markers of the <u>Lincoln Properties Subdivision</u> in Section 20, T6N, R1W, SLB&M. The basis of bearing is a line between the curb nail in the projection of the North Property line of Lot 5 and the curb nail in the projection of the South Property line of Lot 8 assumed to bear South 00°48'52" West.
