

#### NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH THE BOUNDARY FOR IMPROVEMENT PURPOSES. EXISTING FEATURES AND PROPERTY CORNERS FOUND IN THE AREA WERE USED AS WELL AS THE 1919 RECORDED SUBDIVISION PLAT TO LOCATE THE BOUNDARY. BEARINGS SHOWN ARE ROTATED TO STATE PLANE GRID BEARINGS AS PUBLISHED BY WEBER COUNTY, BEARINGS SHOWN IN (PARENTHESIS) ARE RECORD.
