

### RECORD OF SURVEY NARRATIVE

This Survey was requested by Karen Tracy for the purpose of defining the ground location of her adjoining parcels known as Weber County parcel number 01—025—0024 and parcel number 01—025—0023 as was conveyed and recorded in book 1609 page 0040, of the records of the Weber County Recorders Office. The field survey work for this survey was performed in September and October of 2011. The basis of bearing for this survey is a line which bears South 01°19'00" West between the Ogden City Survey monuments at the intersections of 23rd Street and Jefferson Avenue, and 24th street and Jefferson Avenue. At the time of this survey the monuments on 23rd Street were not in place due to construction in the roadway. However, field observations were taken of those monuments for a separate project in September of 2010, and those coordinates were used, as shown, to complete this survey. As is reflected on the Ogden City Engineers Plats, this survey measured an excess amount of property contained within the monuments around Block 29, Plat A. The excess amount measured was distributed proportionately to all the lots and parts of lots within the block. Numerous fence lines and buildings were located, throughout the block, and used to confirm the location of the proportioned property lines. The old house on the north side of the subject parcels appears to have been built with the intention of placing the south edge of the house on the north property line of the subject parcel, which was a typical practice for the narrow properties within cities, in the late 1800's. The fence lines and asphalt parking lot, along the extension of the south line of the house, appear to have been subsequently built further south, beyond the south line of the house, as much as two feet in some places. The location of these fence lines and asphalt parking lot are inconsistent with the evidence of occupation found throughout the rest of the block and appear to be an encroachment onto the subject parcel. The various, inconsistent, fence lines near the south line of the subject parcels seem to have been erected out of convenience, at different times, and with various materials. The location of these fence lines are inconsistent with the evidence of occupation found throughout the rest of the block and were not used as evidence to define the property line. A 5/8" diameter by 24" length rebar with a blue plastic cap stamped "LANDMARK PLS 7897281" was set South 01'19'00" West 0.50 feet from the true position of the northwest property corner of the subject parcels due to an underground sprinkler line directly below the property corner. The other property corners have been set on the ground, with the same type of marker mentioned above, as shown hereon.
