

Narrative:

At the request of Ray Bowden, Manager and Authorized Agent of Alley Enterprise Investment Company, LLC, we have prepared this subdivision plat.

The basis of bearing for this plat is \$ 89°36'57" E between the Brass Caps found at the Northwest corner and the North 1/4 corner of Section 24, Township 6 North, Range 1 East, Salt Lake Base & Meridian, U.S. Survey.

1. 10.00' wide Utility and Drainage Easements each side of Property line as indicated by dashed lines, except as otherwise shown. 2. 20.00' cut and fill easements along front of lots as shown.

3. Centerline monuments to be set upon completion of improvements, as shown

4. Common areas may be used as Public Utility Easements.






