

THE BASIS OF BEARINGS FOR THIS PLAT IS THE SECTION LINE BETWEEN THE SOUTHEAST CORNER AND THE WITNESS MONUMENT FOR THE EAST QUARTER CORNER OF SECTION 22, TOWNSHIP 6 NORTH, RANGE 3 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY. SHOWN HEREON AS \$00°59'35"W 2640.41"

NARRATIVE


THE PURPOSE OF THIS PLAT IS TO CREATE A ONE LOT SUBDIVISION OF THE BELOW DESCRIBED PARCEL OF LAND. ALL BOUNDARY CORNERS WERE SET WITH A 5/8" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES".

BOUNDARY DESCRIPTION

A PART OF THE SOUTHEAST QUARTER OF SECTION 22, TOWNSHIP 6 NORTH, RANGE 3 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE WEST RIGHT-OF-WAY LINE OF 7500 WEST STREET, SAID POINT ALSO BEING S00°42'22"W 1242.36 FEET FROM THE EAST QUARTER CORNER OF SECTION 22; THENCE S00°42'22"W 187.41 FEET TO THE NORTH LINE OF WHITE FARMS SUBDIVISION; THENCE ALONG SAID NORTH LINE THE FOLLOWING FOUR (4) COURSES: (1) N89°55'40"W 474.40 FEET: (2) ALONG A CURVE TURNING TO THE RIGHT WITH AN ARC LENGTH OF 28.82 FEET, A RADIUS OF 830.01 FEET, A CHORD BEARING OF S08°42'28"W, AND A CHORD LENGTH OF 28.81 FEET: (3) N78°14'09"W 157.19 FEET: AND (4) ALONG A CURVE TURNING TO THE LEFT WITH AN ARC LENGTH OF 64.50 FEET, A RADIUS OF 825.00 FEET, A CHORD BEARING OF N80°28'32"W, AND A CHORD LENGTH OF 64.49 FEET; THENCE N00°19'34"W 181.18 FEET; THENCE S89°17'38"E 699.65 FEET TO THE POINT OF BEGINNING.
