

## Narrative

The purpose of this survey was to establish and set the property corners of the parcel as shown and described hereon. The survey was ordered by Ron Beeson. The control used to establish the property corners was the existing Ogden City Monumentation surrounding Block 13, Plat A of the Ogden City Survey located in the Northwest Quarter of Section 33, Township 6 North, Range 1 West, Salt Lake Base & Meridian. The basis of bearing is the monument line of Jefferson from the Intersection of 27th to 26th Street which bears North 00°58'00" East.

## Parcel A

A Part of Lots 1 & 10 Block 13, Plat A, Ogden City Survey


Beginning at a Point Located North 00°58'00" East 166.09 Feet (North 165.00 Feet By Record) and North 89°01'57" West 148.04 Feet (West 147.00 Feet By Record) from the Southeast Corner of said Lot 1 and Running Thence South 00°57'40" West 60.39 Feet (South 60.00 Feet By Record); Thence North 89°02'48" West 101.21 Feet (West 100.50 Feet By Record); Thence North 00°57'31" East 60.41 Feet (North 60.00 Feet By Record); Thence South 89°01'57" East 101.21 Feet (East 100.50 Feet By Record) to the Point of Beginning. Containing 0.140 Acres or 6,113 Square Feet.

## Parcel B

A Part of Lot 1, Block 13, Plat A, Ogden City Survey

Beginning at a Point Located North 89°02'42" West 132.92 Feet (West 132.00 Feet By Record) from the Southeast Corner of said Lot 1 and Running Thence North 89°02'42" West 116.30 Feet (West 115.50 Feet By Record); Thence North 00°57'31" East 105.69 Feet (North 105.00 Feet By Record); Thence South 89°02'48" East 101.21 Feet (East 100.50 Feet by Record); Thence South 00°57'40" West 10.07 Feet (South 10.00 Feet By Record); Thence South 89°02'44" East 15.11 Feet (East 15.00 Feet By Record); Thence South 00°57'43" West 95.62 Feet (South 95.00 Feet By Record) to the Point of Beginning. Containing 0.278 Acres or 12,142 Square Feet.
