

NARRATIVE

THE PURPOSE OF THE SURVEY WAS TO ADJUST THE PROPERTY LINE BETWEEN LOT 20 OF HUNTER'S RUN SUBDIVISION AND CARLOS HESLOP'S PROPERTY TO THE SOUTHWEST OF SAID LOT. THE INTENTION WAS TO SWAP A PORTION OF LOT 20, HUNTER'S RUN SUBDIVISION (PARCEL "C"), FOR A SIMILARLY-SIZED PORTION OF MR. HESLOP'S PARCEL (PARCEL "B"), THUS CREATING A RECTANGULAR LOT IN PLACE OF LOT 20 (LOT 101). THIS WAS DONE BASED ON THE SUBDIVISION MONUMENTS SHOWN FOR HUNTER'S RUN SUBDIVISION. BASIS OF BEARING IS AS SHOWN BETWEEN SUBDIVISION MONUMENTS. TIES TO SECTION CORNERS ARE AS PER THE HUNTER'S RUN SUBDIVISION PLAT.
