



DESCRIPTION OF RECORD

Part of the Northeast Quarter of Section 1, Township 5 North, Range 2 West, Salt Lake Meridian, U.S. Survey: Beginning at a point 2490 feet West along the Quarter Section Line from the Northeast Corner of said Quarter Section; Running Thence South 1094.61 feet, Thence South 67°17' West 173.05 feet to the Quarter Section line, Thence North along the Quarter Section line 1161.45 feet to the North line of said Quarter Section, Thence East 59.63 feet to the place of beginning. Excepting the North 24.75 feet, more or less, There of, lying within the public Road way. Also: excepting therefrom that portion thereof along the Southside which lies South of the North line of the State Highway.

DESCRIPTION OF PROPERTY AS SURVEYED

A part of the Northeast Quarter of Section 1, Township 5 North, Range 2 West, Salt Lake Meridian, U.S. Survey and more particularly described as follows:

Beginning at a point on the South right-of-way line of 3300 South Street, said point being \$00°29'35"W 33.00 feet from the North Quarter corner of said Section 1 and running: Thence along said South right-of-way line of 3300 South Street S89°30'43"E 152.39 feet; Thence S00°29'17"W 1072.09 feet, to the North right-of-way line of the Hinkley Drive; Thence along said North right-of-way line of the Hinkley Drive, S67°32'13"W 189.59 feet to a fence corner; Thence along said fence N01°35'50"E 1146.24 feet to a point on the South right-of-way line of said 3300 South Street and the Point of Beginning.

Contains: 4.15 acres, more or less.

NARRATIVE AND STATEMENT OF PURPOSE

This survey was completed at the request of Bernie Devlin (George Bernard Trust), for the purpose of a site plan.

The boundary was determined with the assistance of two Records of Survey on file at the Weber County Surveyors office. To the West of the subject parcel is Kapp Industrial Park Subdivision Phase 1 & 5 the boundary of which was shown on a May 1994 Record of Survey performed by Gardner Engineering. Part of the Easterly boundary was shown on an April 2000 Record of Survey performed by Great Basin Engineering.

The Basis of Bearing is from Weber County Monument Control as shown on this drawing.
