BOUNDARY DESCRIPTION

BEGINNING AT A POINT 1263.56 FEET (1238.040 FEET PER DEED) SOUTH AND 2608,11 FEET (2626.451 FEET PER DEED) EAST FROM THE NORTHWEST CORNER OF SECTION 3, TOWNSHIP 7 NORTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN, ON THE CENTER OF AN EXISTING ROAD, THENCE LEAVING THE ROAD AND RUNNING THENCE SOUTH 84°41'25" EAST 849.78 FEET TO THE CENTER OF BEAVER CREEK AND ALONG THAT CREEK FOR THREE (3) COURSES! SOUTH 12°52'30" EAST 60.00 FEET, SOUTH 12°31'44" WEST 92.20 FEET, SOUTH 8°19'32" EAST 107.61 FEET, THENCE LEAVING THE CREEK NORTH 82°57'27" WEST 881.20 FEET TO THE CENTER OF ROAD AND ALONG THAT ROAD CENTERLINE FOR TWO (2) COURSES!
