
# OAK VIEW ESTATES PHASE 4 LOT LINE AMENDMENT

TOWNSHIP 5 NORTH, RANGE 1 WEST, OF THE SALT LAKE BASE AND MERIDIAN



#### **BOUNDARY DESCRIPTION**

BEGINNING AT THE NORTHWEST CORNER OF LOT 47, OAK VIEW ESTATES PHASE 4, SAID POINT ALSO BEING SOUTH 1793.05 FEET AND EAST 655.48 FEET FROM THE NORTH QUARTER CORNER OF SECTION 10. TOWNSHIP 5 NORTH, RANGE I WEST, OF THE SALT LAKE BASE AND MERIDIAN.

RUNNING THENCE NORTH 77°35'00" EAST 8.44 FEET TO A TANGENT CURVE TO THE LEFT, THENCE NORTHEASTERLY 196.67 FEET ALONG SAID CURVE TO A NON TANGENT LINE (DELTA = 11°19'22", RADIUS = 964.82 FEET, TANGENT 95.65 FEET, CHORD BEARS NORTH 71°54'23" EAST 190.36 FEET; THENCE SOUTH 30°54'00" EAST 103.58 FEET TO THE NORTH LINE OF LOT 37 OAK VIEW ESTATES PHASE THREE; THENCE SOUTH 70°03'33" WEST 61.12 FEET ALONG THE NORTH LINE OF SAID LOT 37; THENCE SOUTH 31°05'41" WEST 156.92 FEET ALONG SAID LOT 37 TO A NON TANGENT CURVE TO THE RIGHT: THENCE ALONG SAID CURVE TO A TANGENT LINE, (DELTA = 37°29'34", RADIUS = 125.00 FEET, TANGENT = 42.42 FEET, CHORD BEARS NORTH 31°44'47" WEST 80.34 FEET: THENCE NORTH 13°00'00" WEST 21.76 FEET TO A TANGENT CURVE TO THE LEFT; THENCE ALONG SAID CURVE TO A REVERSE CURVE (DELTA = 58°00'00", RADIUS = 150.00 FEET, TANGENT = 83.15 FEET, CHORD BEARS NORTH 42°00'00" WEST 145.44 FEET; THENCE NORTHWESTERLY 15.40 FEET ALONG SAID REVERSE CURVE TO A TANGENT LINE (DELTA = 59°32'39", RADIUS = 14.82 FEET, TANGENT = 8.48 FEET, CHORD BEARS NORTH 41°24'27" WEST 14.72 FEET; THENCE NORTH 12°25'00" WEST 94.96 FEET TO THE POINT OF BEGINNING. TOWNSHIP 5 NORTH RANGE I WEST, OF THE SALT LAKE BASE AND MERIDIAN.

RUNNING THENCE NORTH 75°08"42" EAST 34.86 FEET; THENCE NORTH 84°20'31" EAST 19.68 FEET; THENCE SOUTH 25°36'58" WEST 57.06 FEET TO SAID EASTERLY RIGHT-OF-WAY LINE; THENCE ALONG SAID RIGHT-OF-WAY LINE NORTHWESTERLY ALONG THE ARC OF A 150.00 FOOT RADIUS CURVE 49.87 FEET, HAVING A CENTRAL ANGLE OF 19°03'04", CHORD BEARS NORTH 35°11'14" WEST 49.64 FEET TO THE POINT OF BEGINNING.
