

SURVEYOR'S CERTIFICATE

NARRATIVE

THE PURPOSE OF THIS PLAT IS TO LOCATE ON THE GROUND THE BELOW DESCRIBED PARCELS OF LAND AS SHOWN HEREON.

BASIS OF BEARINGS

THE BASIS OF BEARINGS FOR THIS PLAT IS THE SECTION LINE BETWEEN A FOUND BRASS CAP WITNESS CORNER MONUMENT TO THE NORTH QUARTER CORNER AND A FOUND BRASS CAP WITNESS CORNER MONUMENT AT THE NORTHEAST OF SECTION 18, TOWNSHIP 6 NORTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY. SHOWN HEREON AS: N89°13'15"E

SURVEYOR'S NOTES

THE DEED DESCRIPTIONS DO NOT MATCH THE PRIOR SURVEY PREPARED BY BUTTARS SURVEYING. WE MATCHED THE REBAR AND CAPS SET BY BUTTARS WHENEVER POSSIBLE AS THAT IS WHERE THE PARCEL LINES HAD BEEN DETERMINED IN 1991 AND 1994. THE DEED LINES ALSO DO NOT MATCH AS DESCRIBED. THE NORTH LINE WAS PLACED ALONG THE ESTABLISHED FENCE LINE. THE EAST LINE OVERLAPS THE WEBER COUNTY PARCEL 24-018-0038 WHICH LANDS WEST OF THE BUTTARS CAPS, WE RECOMMEND A BOUNDARY LINE AGREEMENT BE PROPOSED TO WEBER COUNTY TO REVISE TO THE OCCUPIED LOCATION. THE SOUTH LINE DOES NOT MATCH THE FENCE WHICH LOOKS TO BE PLACED OUT OF CONVENIENCE.

THE SOUTHEAST CORNER AND WITNESS CORNER TO THE SOUTHEAST CORNER ARE NOT IN, CALCULATIONS WERE MADE FROM THE AVAILABLE REFERENCE MONUMENTS AND WITNESS CORNER MONUMENTS TO ESTABLISH IT'S POSITION.


