

THE PURPOSE OF THIS PLAT IS TO LOCATE AND MARK ON THE GORUND THE NORTH LINE OF WEBER COUNTY PARCEL NO. 09-068-0007 AND THE SOUTH LINE OF WEBER COUNTY PARCEL NO. 09-068-0005 AS SHOWN ON THIS PLAT.

PARCEL DESCRIPTIONS

PARCEL 09-068-0007 (ENTRY NO. 2614343)

PART OF THE SOUTHEAST QUARTER OF SECTION 15, TOWNSHIP 5 NORTH, RANGE 2 WEST, SALT LAKE MERIDIAN, U.S. SURVEY, BEGINNING AT A POINT 400 FEET SOUTH FROM THE NORTHEAST CORNER OF SAID QUARTER SECTION, RUNNING THENCE SOUTH 65 FEET, THENCE WEST TO THE EAST LINE OF THE D&RGW RR RIGHT OF WAY, THENCE NORTHERLY ALONG SAID RIGHT OF WAY TO A POINT WEST OF BEGINNING, THENCE EAST TO THE PLACE OF BEGINNING. EXCEPT THE COUNTY ROAD RUNNING ALONG THE EAST SIDE THEREOF.


PARCEL 09-068-0005 (ENTRY NO. 2437991)

A PART OF THE SOUTHEAST QUARTER OF SECTION 15, TOWNSHIP 5 NORTH, RANGE 2 WEST, SALT LAKE MERIDIAN, U.S. SURVEY: BEGINNING AT A POINT 270 FEET SOUTH FROM THE NORTHEAST CORNER OF SAID QUARTER SECTION AND RUNNING THENCE SOUTH 65 FEET; THENCE WEST TO THE EAST LINE OF THE D. & R.G.W. RAILROAD RIGHT OF WAY; THENCE NORTHERLY ALONG SAID RIGHT OF WAY TO A POINT WEST OF THE BEGINNING; THENCE EAST TO THE PLACE OF BEGINNING. EXCEPTING COUNTY ROAD RUNNING ALONG THE EAST SIDE THEREOF.
