


BASIS OF BEARINGS

THE BASIS OF BEARINGS FOR THIS PLAT IS N89°43'31"W BETWEEN THE NORTHEAST AND THE NORTHWEST CORNERS OF SECTION 26, TOWNSHIP 5 NORTH, RANGE 1 WEST, SLB&M.

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO MARK THE BOUNDARY AS SHOWN HEREON. THE BOUNDARY WAS DETERMINED BY RETRACING DEEDS USING OCCUPATIONAL EVIDENCE, RAILROAD TRACKS, EXISTING MONUMENTS, AND A 2003 LANDMARK SURVEY OF THE SUBJECT PROPERTY, WHICH MATCHED A 2002 REEVE SURVEY ON THE PROPERTY ADJACENT TO AND SOUTH OF THE SUBJECT PROPERTY. THE SOUTHEAST CORNER OF SECTION 26 WAS NOT FOUND, BUT USING RECORD TIES TO THE NORTHEAST AND THE NORTHWEST CORNERS OF SECTION 26, WE FIT THE LOCATION OF THE BUILDING AS SHOWN ON SAID LANDMARK SURVEY AND THE LOCATION OF THE RAILROAD.

BOUNDARY DESCRIPTION


PART OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 26, TOWNSHIP 5 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN.

BEGINNING AT A POINT ON THE SOUTH LINE OF THE UNION PACIFIC RAILROAD RIGHT OF WAY, SAID POINT BEING 3058.22' S0*29'52"E AND 505.16' N74*15'52"W AND 431.94' N17*24'08"E AND 616.71' N73*47'52"W FROM THE NORTHEAST CORNER OF SAID SECTION 26 AND RUNNING THENCE; S17*30'08"W 145.22'; THENCE N60*43'35"W 50.55'; THENCE N76*49'42"W 147.65'; THENCE N26*37'40"W 193.02'; THENCE \$73*47'52"E 331.20' TO THE POINT OF BEGINNING.
