THE SOUTHERLY HALF OF THE BOUNDARY COMMON TO SECTIONS 32 AND 33 IS SHOWN ON THE SURVEYS LISTED IN "RECORD DATA" HEREON. THE SECTION CORNER MONUMENT AT THE SOUTH END OF THE LINE IS DESCRIBED IN NOTE 4. THE QUARTER CORNER COMMON TO SECTIONS 32 AND 33 WAS RECOVERED AS SHOWN ON THE SURVEYS NOTED IN RECORD DATA. SIX UNDISTURBED MONUMENTS WERE RECOVERED ALONG THE SOUTHWEST RIGHT-OF-WAY OF HIGHWAY 226. ONE MONUMENT ALONG THE PORTION OF RIGHT-OF-WAY SURVEYED WAS NOT FOUND.
