## RECORD DESCRIPTION

PART OF THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 7, TOWNSHIP 5 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY:

BEGINNING AT A POINT ON THE NORTH LINE OF GRANTOR'S LAND IN THE CENTER OF THE HOOPER CANAL, WHICH IS 34.36 CHAINS EAST AND 15.51 CHAINS NORTH FROM THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 7, TOWNSHIP 5 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY:
RUNNING THENCE SOUTH 290.4 FEET ALONG THE CENTERLINE OF SAID CANAL; THENCE WEST 150 FEET; THENCE NORTH 290.4 FEET TO THE NORTH LINE OF GRANTOR'S LAND; THENCE EAST 150 FEET TO THE POINT OF BEGINNING.

PART OF THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 7, TOWNSHIP 5 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY:

BEGINNING AT A POINT ON THE NORTH LINE OF GRANTOR'S LAND IN THE CENTER OF THE HOOPER CANAL & 4600 SOUTH STREET, SAID POINT BEING SOUTH 89°38′25″ EAST 2273.68 FEET ALONG THE SECTION LINE AND NORTH 02°04′35″ EAST 986.34 FEET FROM THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 7, AND RUNNING THENCE SOUTH 02°04′35″ WEST 290.50 FEET ALONG THE CENTERLINE OF SAID CANAL TO THE BOUNDARY LINE OF AURORA ESTATES PHASE 3; THENCE THE FOLLOWING TWO (2) COURSES ALONG SAID BOUNDARY LINE, (1) NORTH 88°51′44″ WEST 150.00 FEET TO A FENCE CORNER, (2) NORTH 02°04′35″ EAST 290.50 FEET TO THE NORTH LINE OF GRANTOR'S LAND IN THE CENTER OF 4600 SOUTH STREET; THENCE SOUTH 88°51′44″ EAST 150.00 FEET ALONG SAID NORTH LINE TO THE POINT OF BEGINNING.
