

LOT 4 **BOUNDARY DESCRIPTION**

ALL OF LOT 4, BLOCK 24, PLAT "A" HUNTSVILLE SURVEY, BEING LOCATED IN THE NORTHEAST QUARTER OF SECTION 13, TOWNSHIP 6 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE EASTERLY RIGHT-OF-WAY LINE OF 6800 EAST STREET BEING LOCATED SOUTH 0°00'00" EAST 885.56 13; RUNNING THENCE NORTH 88°47'49" EAST 247.33 FEET; THENCE SOUTH 1°12'11" EAST 131.98 FEET THENCE SOUTH 88°47'49" WEST 247.34 FEET TO THE EASTERLY RIGHT-OF-WAY LINE OF SAID 6800 EAST STREET; THENCE ALONG SAID RIGHT-OF-WAY LINE NORTH 1°12'11" WEST 131.98 FEET TO THE POINT OF BEGINNING. CONTAINING 32,643 SQ.FT. OR 0.75 ACRES, MORE OR LESS.

ALL OF LOT 5, BLOCK 24, PLAT "A" HUNTSVILLE SURVEY, BEING LOCATED IN THE NORTHEAST QUARTER OF SECTION 13, TOWNSHIP 6 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF SAID LOT 5, BEING ON THE SOUTHERLY RIGHT-OF-WAY LINE OF FIRST STREET AND THE EASTERLY RIGHT-OF-WAY LINE OF 6800 EAST STREET BEING LOCATED SOUTH 0°00'00" EAST 753.61 FEET AND NORTH 0°00'00" EAST 902.06 FEET FROM THE NORTH QUARTER CORNER OF SAID SECTION 13; RUNNING THENCE ALONG THE SOUTHERLY RIGHT-OF-WAY LINE OF SAID FIRST STREET NORTH 88°47'49" EAST 247.33 FEET; THENCE SOUTH 1°12'11" EAST 131.99 FEET; THENCE SOUTH 88°47'49" WEST 247.34 FEET TO THE EASTERLY RIGHT-OF-WAY LINE OF SAID 6800 EAST STREET: THENCE ALONG SAID RIGHT-OF-WAY LINE NORTH 1°12'11" WEST 131.99 FEET TO THE POINT OF BEGINNING. CONTAINING 32,645 SQ.FT. OR .075 ACRES, MORE OR LESS.




THE PURPOSE OF THE SURVEY WAS TO ESTABLISH THE BOUNDARY OF THE LOTS AS SHOWN AND FIELD FOR THE CREATION OF EASEMENTS FOR THE BENEFIT OF LOT 5. THE CONTROL USED TO SHOWN AND NOTED HEREON. THE BASIS OF BEARING IS THE NORTH LINE OF THE NORTHEAST QUARTER OF SECTION 13, TOWNSHIP 6 NORTH, RANGE 1 EAST, OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS SOUTH 89°13'07"" EAST WEBER COUNTY GRID BEARING.
