


A PART OF THE SOUTHWEST QUARTER OF SECTION 19, TOWNSHIP 7 NORTH, RANGE 1 WEST, OF THE

FEET (1939.31 FEET BY RECORD) ALONG THE WEST LINE OF SAID SECTION 19 AND NORTH 90°00'00" EAST 81.98 FEET (S89°11'25"E 69.93 FEET BY RECORD); RUNNING THENCE NORTH 28°08'57" EAST (N28°03'E BY RECORD) 150.68 FEET; THENCE SOUTH 66°08'02" EAST 540.88 FEET (S66°05'43"E 550.70 FEET BY RECORD) TO THE WESTERLY RIGHT-OF WAY LINE OF 1100 WEST STREET; THENCE ALONG SAID WESTERLY RIGHT-OF-WAY LINE SOUTH 23°58'59" WEST 156.13 FEET (S23°28'W 162.86 FEET BY RECORD); THENCE NORTH 66°40'00" WEST 248.56 FEET (269.6 FEET BY RECORD); THENCE SOUTH 23°25'04" WEST 140.39 FEET (\$23°28'00"W 140.41 FEET BY RECORD); THENCE NORTH 66°41'05" WEST 316.48 FEET (N66°40'00"W 321.88 FEET BY RECORD); THENCE NORTH 28°25'40" EAST 152.09 FEET (N28°30'00"E 140.98 FEET BY RECORD) TO THE POINT OF BEGINNING. CONTAINING 2.992 ACRES.

PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY KELLY MILES FROM THE RECOMMENDATION OF LINCOLN TITLE. THE CURRENT VESTING DEED CONTAINS A CLOSING ERROR OF 24.51 FEET. THE MEETS AND BOUNDS DESCRIPTION OF THE SUBJECT PROPERTY HAS CHANGED MULTIPLE TIMES SINCE THE PARCEL WAS CREATED AND THE MAJORITY OF THE HISTORICAL DESCRIPTIONS CONTAIN MIS-CLOSURES AND ERRORS IN THE SECTION TIE. ADJOINING DEEDS, RECORDED SURVEYS, AND FOUND PROPERTY CORNERS WERE RELIED UPON IN DETERMINING THE BOUNDARY. OCCUPIED FENCE LINES IN THE AREA CLOSELY MATCH DISTANCES CONTAINED IN DEEDS ALONG 1100 WEST. THE RIGHT-OF-WAY OF 1100 WEST WAS ESTABLISHED BY ROAD DEDICATION PLAT RECORDED AS ENTRY #383929 BOOK 13 OF PLATS PAGE 11 JULY 26, 1962. THE BASIS OF BEARING IS THE SOUTH LINE OF SECTION 19, TOWNSHIP 7 NORTH, RANGE 1 WEST, OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS SOUTH 89°34'55" EAST, WEBER COUNTY, UTAH
