

BOUNDARY DESCRIPTIONS

Parcel 1 Boundary Description

A part of the Northwest Quarter of Section 2, Township 6 North, Range 1 East. Salt Lake Base and Meridian, U.S. Survey: Beginning at a point on the existing South Right of way line of 1900 North

Street, said point being 1906.57 feet North 89°15'29" West along the Section line and 42.45 feet South 0.50'50" West from the Northeast corner of said Quarter Section and running thence South 00°50'50" West 40.00 feet; thence South 35°50'10" East 277.60 feet; thence South 04°43'44" East 1020.62 feet to an Existing fence line as described in that certain boundary line agreement E# 2377864; thence North 89°29'25" West 229.49 feet along said fence line to an existing fence line; thence seven (7) courses along said fence line as follows: (1) North 00°48'42" East 204.56 feet; (2) North 00°17'59" East 302.04 feet; (3) North 00°26'25" East 288.43 feet; (4) North 00°16'35" West 211.54 feet; (5) North 27°21'08" West 182.64 feet; (6) North 57'20'56" West 141.18 feet; and (7) North 00'50'50" East 37.88 feet to said South right of way line; thence South 89°09'10" East 179.98 feet along said South right of way line to the point of beginning.


