



#### VICINITY MAP NOT TO SCALE



#### **BASIS OF BEARINGS**

THE BASIS OF BEARINGS FOR THIS PLAT IS THE CENTERLINE BETWEEN THE FOUND HOOPER CITY MONUMENT (95-6) IN THE INTERSECTION OF 5900 SOUTH STREET AND 5700 WEST STREET AND THE FOUND HOOPER CITY MONUMENT (95-1) IN THE INTERSECTION OF 5500 SOUTH STREET AND 5700 WEST STREET. SHOWN HEREON AS

### **NARRATIVE**

THE PURPOSE OF THIS PLAT IS TO REESTABLISH THE BOUNDARY OF THE MICHAEL LANDON PROPERTY. IT APPEARS THAT THE LINES OF OCCUPATION WERE ESTABLISHED FROM THE CENTERLINE SPLIT OF PAVEMENT ON 6100 WEST STREET AND 5700 SOUTH STREET THAT PUTS THEM 16.5 FEET MORE OR LESS EAST AND 23.0 FEET MORE OR LESS NORTH OF THE ACTUAL DEED LOCATION FOR THE BLOCK LOCATION USING THE MONUMENTATION FROM THE ORIGINAL HOOPER TOWNSITE SURVEY OF 1910 AND THE RESURVEY DONE BY MARTIN MOORE JR. THE EAST LINE OF BLOCK 6 WAS ESTABLISHED 49.5 FEET WEST OF THE PAVEMENT CENTERLINE OF 6100 WEST STREET AND THE NORTH LINE OF SAID BLOCK 33.00 FEET SOUTH OF THE PAVEMENT CENTERLINE OF 5700 SOUTH STREET, THE SOUTH AND WEST LINE BY DEED. ALL BOUNDARY CORNERS WERE SET WITH A %" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES".
