


BASIS OF BEARINGS

THE BASIS OF BEARINGS FOR THIS PLAT IS THE LINE BETWEEN A FOUND OGDEN CITY MONUMENT AT THE INTERSECTION OF 30TH STREET AND CIRCLE WAY AND A FOUND OGDEN CITY MONUMENT AT THE INTERSECTION OF 30TH STREET AND POLK AVENUE. SHOWN HEREON AS: \$89.08.16."E

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MARK THE PROPERTY CORNERS ON THE GROUND. THE BOUNDARY WAS DETERMINED BY RETRACING THE HILLCREST ADDITION TO OGDEN CITY AND MATCHING THE PLATTED LINES WITH EXISTING OCCUPATION AND IMPROVEMENTS ON THE GROUND. THE SOUTHERLY LINE OF THE SUBJECT PARCEL RUNS ALONG THE TOP OF THE EXISTING RETAINING WALL. THE EXISTING FENCE WAS BUILT ON TOP OF THE WALL AND EXTENDED SOUTHERLY AND IS OFF THE PLATTED PROPERTY LINE AS SHOWN. THE LOCATION OF THE WALL WAS USED TO CONFIRM THE PROPERTY LINE AS IT WAS BUILT PRIOR TO THE FENCE. ALL PROPERTY CORNERS WERE MARKED AS SHOWN.




