BEGINNING AT A POINT ON THE EASTERLY RIGHT-OF-WAY LINE OF ECCLES AVENUE BEING LOCATED NORTH 88°42'35" WEST 379.43 FEET ALONG THE MONUMENTED CENTERLINE OF 23RD STREET BETWEEN THE OGDEN CITY CENTERLINE MONUMENT AT 23RD STREET AND VAN BUREN AVENUE AND THE OGDEN CITY CENTERLINÉ MONUMENT AT 23RD STREET AND ECCLES AVENUE AND NORTH 1°17'39" EAST 191.27 FEET ALONG THE CALCULATED CENTERLINE OF ECCLES AVENUE AND NORTH 90°00'00" EAST 33.01 FEET FROM THE CENTERLINE MONUMENT AT 23RD STREET AND VAN BUREN AVENUE; RUNNING THENCE ALONG SAID RIGHT-OF-WAY LINE NORTH 1°17'39" EAST 26.09 FEET; THENCE SOUTH 88°42'35" EAST 140.00 FEET; THENCE SOUTH 1°17'23" WEST 26.09 FEET; THENCE NORTH 88°42'35" WEST 140.00 FEET TO THE POINT OF




NARRATIVE

THE PURPOSE OF THE SURVEY WAS TO ESTABLISH THE PROPERTY BOUNDARY FOR PARCEL NO. 02-037-0063 AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY PEG HOOVER. THE CONTROL USED TO ESTABLISH THE BOUNDARY WAS THE EXISTING OGDEN CITY CENTERLINE MONUMENTATION AS SHOWN AND NOTED HEREON. CURRENT VESTING DEED RECORDED AS E#2711692, AS WELL AS ADJACENT DEEDS AND CURRENT OCCUPATION WERE ALSO USED. THE BASIS OF BEARING IS THE LINE BETWEEN THE OGDEN CITY CENTERLINE MONUMENT AT 23RD STREET AND VAN BUREN AVENUE AND THE OGDEN CITY CENTERLINE MONUMENT AT 23RD STREET AND ECCLES AVENUE WHICH BEARS NORTH 88°42'35" WEST WEBER COUNTY GRID BEARING.
