

Narrative

THE PURPOSE OF THIS SURVEY IS TO MARK THE PROPERTY BOUNDARIES ON THE GROUND. THE NORTH LINE OF THE PARCELS ARE TO THE SECTION LINE. THE RIGHT OF WAY LINE SHOWN HEREON IS AN EXTENSION OF UDOT PARCEL DEEDED FROM 10-045-0052. THERE ARE CONFLICTS IN THE MATH AND IN THE OCCUPATION IN THE PARCELS TO THE EAST AND WEST THE LINES SHOWN HEREON ARE ALONG THE LONGSTANDING FENCE AND OCCUPATION LINES AND BOUNDARY BY ACQUIESCENCE WAS USED TO DETERMINE SAID LINES, AS THE FENCING WAS OVER 20 YEARS OLD AT THE TIME OF THE SURVEY. THE SOUTH LINE, OR THE NORTH LINE OF THE SOUTHERN PACIFIC RAILROAD COMPANY, WAS DETERMINED BY OFFSETTING 50' FROM THE CENTERLINE OF THE SOUTHERLY TRACKS, WHICH LINE FALLS VERY NEAR THE FENCING ALONG THE RIGHT OF WAY AS SHOWN AND ALSO MATCHED THE FENCING TO THE SOUTH. BOUNDARY LINE AGREEMENTS ALONG THE EAST AND WEST ARE RECOMMENDED TO CLEAR UP POTENTIAL TITLE ISSUES IN THE FUTURE IF THESE PARCELS WERE TO BE DEVELOPED.







Vicinity Map (NOT TO SCALE)


